## University of Indy Students Support HB 1467

This month the UIndy Student Athletic Training Club did a petition drive on campus in support of our state legislation. The students collected signatures of nearly 150 students and sent emails to friends/family, etc asking for support. The petition was sent to all senators on the insurance and health services committees. To date we have confirmed 47 contacts with senators by email and almost 3000 contacts (10 senators on each committee x 150 names on petition - students received reply form letters from some of the senators) by petition.

## HB 1467 Update

House Bill 1467 passed the full Senate with a 50-0 vote. There were some language modifications and HB 1467 was re-confirmed in the House of Representatives 91-1. Our legislation now goes to Governor Daniels for signing.

Below is a synopsis of Indiana's Bill for Athletic Trainer Reimbursement.

"Requires reimbursement under a policy of accident and sickness insurance or health maintenance organization contract for certain services that are covered under the policy or contract and are provided by a licensed athletic trainer under the athletic trainer's scope of practice."

There were additional clarifications and minor exclusions to our Bill. This legislation applies to insurance written after June 30, 2011, or when the insurance policy renews. Understand there may be a phase in period for these reimbursement changes. You can view the entire **HB 1467** at...

## **BOC Update**

The BOC is revising the recertification requirements for BOC Certified Athletic Trainers. You probably received a letter from them in the past couple of weeks, but if not here are the highlights:

- Recertification Fee The BOC has always offered a discount to NATA members and will continue this practice. However, the way in which the NATA collects the fee on behalf of its members is changing. The only thing an NATA member has to do to obtain the 32% discount is to be sure that the BOC recertification fee is checked at the time of NATA renewal. The \$34 discounted fee will be added to the dues amount. NATA will make this process easy and seamless.
- Continuing Education (CE) Guidelines The current CE guidelines have been extended through 12/31/2013.
- Simple CE Reporting Form The new CE form will require simple data entry only.
- Certification Statuses The nine current statuses will be replaced by four sim
  plified statuses. As a result, the Professional Practice and Disciplinary Guide
  lines and Procedures will be updated.
- Expiration Date The BOC will be returning to one common expiration date for AT recertification. Please note that ATs with a 2011 expiration date are still re quired to complete and report required CE by the end of 2011.

## Hit the Hill

On February 26th, 2011 more than 225 certified athletic trainers and 150 athletic training students from 42 states attended the annual NATA Hit the Hill day to advocate for federal legislation on behalf of the NATA. Six certified athletic trainers (including IATA President John Locke, IATA President-Elect Scott Lawrance, IATA Past-President Craig Voll, and IATA Secretary Jessica Emlich) from Indiana attended the event meeting with representatives from Senator Lugar and Senator Coats offices as well as with staff members of each of their individual House Representative. Among the legislative items advocated for were H.R. 6172 – Protecting Student Athletes from Concussions Act and H.R. 1347 – Concussion Treatment and Care Tools (ConTACT) Act.

H.R. 6172 would require school districts to implement concussion management plans to ensure students are informed about concussions and given the support they need to recover. The legislation is specifically designed to increase awareness of concussion signs, symptoms, and risks and improve concussion safety and management for student athletes. Additionally, it states a health care provider (such as a physician or athletic trainer) must be consulted prior to returning an injured athlete to play.

H.R. 1347 is a bill that amends the Public Health Service Act to require the Secretary of Health and Human Services to establish and publish concussion management guidelines in school-aged children, including standards for return to play. It authorizes grants to states for concussion education and preseason baseline and post-injury testing. Lastly, it requires states receiving grants to utilize applicable expertise and services offered by groups such as athletic trainer associations in the development of concussion management guidelines.

## 4th Annual Orthopedic Symposium General Program Description

Issues related to the hip and knee will be the focus of the Fourth Annual Orthopedic Symposium at the new J.W. Marriott in downtown Indianapolis on Friday, September 23. Dr. J.W. The theme will carry over to our afternoon lab sessions, each specifically designed for physicians and rehabilitation specialists.
